Annual Levy Ordinance NO. FY25 – 03 (2024/2025)

AN ORDINANCE FOR THE LEVY OF TAXES FOR THE TAX YEAR 2024 FOR THE LEMONT PUBLIC LIBRARY DISTRICT

COOK AND DUPAGE COUNTIES, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Lemont Public Library District of Cook and DuPage Counties, Illinois, that:

SECTION 1: That taxes in the aggregate sum of \$2,303,250.00 be and the same are hereby levied upon all taxable property within the corporate limits of the LEMONT PUBLIC LIBRARY DISTRICT, in Cook and DuPage Counties, Illinois, subject to taxation for the year 2024 for the several corporate objects and purposes of said District and in the amounts hereinafter set forth, to wit:

Section 5: This Ordinance shall be in full force and effect from and after its passage and approval in accordance with law and shall be known as Ordinance FY25-03.



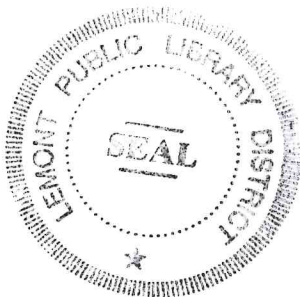
